Scrutiny of nominations	: 4:00 P.M. on Monday, 16 <sup>th</sup> Sep., 2019
Circulation of list of valid nominations	: 03:00 P.M., Tuesday, 17 <sup>th</sup> Sep., 2019
Last date and time for withdrawal of nomination	: By 6.00 P.M., Friday, 27 <sup>th</sup> Sep., 2019

After the withdrawals, if valid nominations received are more than 18 (Eighteen), the final list of contestants will be circulated to all the eligible Regular Members along with the Ballot Paper on **5<sup>th</sup> October 2019**, returnable upto **6.00 P.M.**, Wednesday, on **16<sup>th</sup> October 2019**.

The Locked Ballot Box containing Ballot Papers will be opened at **3.00 P.M., Thursday, on 17th Oct 2019**, by the Returning Officer and the results will be declared on **same day**, alongwith the notification about the constitution of the new Governing Council for the term 2019-2021.
